# **Certificate of ROHS2 Compliance for Monitors Concerning the 3D Pluraview Stereo Monitor and Side Monitors**

#### I. RoHS Directive

The Directive 2011/65/EU of the European Parliament and Council of 8 June 2011 on the restrictions of the use of certain hazardous substances in electrical and electronic equipment is hereinafter referred to as the RoHS Directive. The RoHS Directive bans the placing on the EU market of new Electrical and Electronic Equipment (EEE) containing more than the set levels of lead, cadmium, mercury, hexavalent chromium and both polybrominated biphenyl (PBB) and polybrominated diphenyl ethers (PBDE) flame retardants from 1 July 2006.

### II. Use of RoHS Controlled Substances

For purposes of this Certificate the following definitions apply:



The term homogeneous is understood as of uniform composition throughout, so examples of homogeneous materials would be individual types of plastics, ceramics, glass, metals, alloy, paper, board, resins and coatings.
- The term mechanically disjointed means that the materials can be, in principle, separated by mechanical actions such as unscrewing, cutting, crushing, grinding and abrasive processes.
